Personal data being processed are related to images taken by video surveillance system installed in the company's areas. Each camera is recognizable and it is appropriately indicated by signs placed in the surrounding areas. Images won't be stored nor recorded.

#### PURPOSE AND LEGAL BASIS OF DATA PROCESSING

Being the surrounding area wide and isolated, images recording is due to property protection and to access control inside the company's spaces. Processing legal basis is the data controller's pursuit of legitimate interest (GDPR, Art. 6, Par. 1, letter f).

# DATA PROCESSING LOCATION

Your data will be processed inside EU countries and relevant processing activities won't be mainly carried out through electronic tools.

### DATA DISCLOSURE TO THIRD PARTIES

Images taken by video-surveillance system are visible to personnel of a security company appointed by Scorza for the access control service and, whether IT system maintenance is required, to the company appointed for technical assistance, which operates through a confidentiality agreement. These parties are identified as subjects authorized by security and maintenance operators (Data processors).

Images can be consulted by subjects expressly authorized to data processing.

PERSONAL DATA RETENTION METHOD AND PERIOD

Images won't be stored nor recorded.

### **YOUR RIGHTS**

It is your right to request and receive, in any moment, information and/or rectification upon your personal data processed by Scorza. If applicable, it is your right to request data cancellation or processing restriction and to receive relevant personal data in structured format, for common use and reading; it is also your right to object to your data processing, in compliance with Art. 21 of GDPR, or to file a complaint to Privacy Authority in accordance with Art. 77 of GDPR.
